In the course of this series, representatives of the faculty, alumni and other friends of the Summer School will share their particular insight and experience with you, and invite you for a discussion in the spirit of the Summer School.

About the topic: In order to meet the EU climate and policy as well as Paris Agreements objectives European economies must become climate neutral by 2050 at the latest. EU adopted a Sustainable Finance Package to help moving the flow of money towards sustainable activities across the European Union. Enabling investors to re-orient investments towards more sustainable technologies and businesses will be instrumental in making Europe climate neutral by 2050. The presentation will focus on the role of taxonomy and Just Transition Fund as key measures enabling transition towards climate neutrality.

About the speaker: Natalia Plaskiewicz (LL.M., advocate) is a Summer School Alumna and an associate in the Energy Team, Energy & Infrastructure Practice at the Polish law firm Domański Zakrzewski Palinka. Natalia was a regulatory lawyer at the Polish Energy Group and was seconded to Eurelectric where she worked as policy advisor to the Electrification & Sustainability and Generation & Environment Committees. She has participated in legislative work on a number of acts in Poland and in Brussels, e.g. on the Winter Package (Clean Energy Package), the European Green Deal, budget regulations for the new 2021-2027 budget horizon, the Just Transition Fund, funds under the EU ETS Directive – Innovation Fund and Modernisation Fund, the Sustainable Finance Package (Taxonomy Regulation) and the Climate Law. Natalia has been focusing on sustainable finance and ESG strategies.

About the Summer School: Initiated by the [Energy Community Secretariat](#) in autumn 2015, the Energy Community Summer School aims to promote the development of participants' competences in all topics related to energy through a dedicated multi-disciplinary programme.
